

**NOTICE OF PRE-INQUIRY CHANGES/TECHNICAL OMISSIONS TO THE  
FINALISED WEST LOTHIAN LOCAL PLAN 2005**

**Finalised West Lothian Local Plan 2005**

On 7 March 2006 West Lothian Council's Enterprise and Development Committee approved further changes to the Finalised West Lothian Local Plan 2005 (originally approved on 19 April 2005) and omissions. The council is now making these changes available for inspection to allow the submission of objections.

The statutory requirement is to place the local plan pre-inquiry changes "on deposit" for six weeks to allow for the submission of objections to these changes. The closing date for objections is therefore Friday 21 April 2006.

From Friday 10 March 2006, these proposed pre-inquiry changes/omissions to the finalised local plan can be viewed at all libraries in West Lothian, and all Council Information Services (CIS) offices, as well as at County Buildings, Linlithgow, and West Lothian House, Almondvale Boulevard, Livingston (Monday to Thursday 0830-1700 & Friday 0830-1600). Alternatively, the local plan itself and the pre-inquiry changes/omissions can be viewed on the council's web-page. The address is provided below.
